Update from AERE President Dan Phaneuf

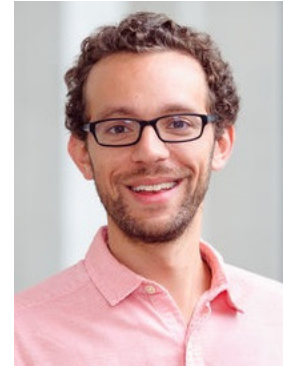
Greetings AERE members and Happy New Year! I thought I would take this opportunity to update you on a few things, beginning with our program at the 2019 ASSA meeting.

A Letter from the Editors of JAERE

Dear AERE members,

We write with several exciting announcements from the Journal of the Association of Environmental and Resource Economists (JAERE).

New Content

We just released volume 6, number 1 of the 2019 issues of JAERE, and vol. 6 no. 2 is on the way in March. As AERE members, you have free access to JAERE articles, but you might also want to share with non-AERE colleagues our excitement about free content in every issue (in this January issue, “Price Regulation and Environmental Externalities: Evidence from Methane Leaks” by Catherine Hausman and Lucija Muehlenbachs). [Free content](#) from each issue can be accessed by anyone through the JAERE website.

More Content

Starting in 2019, JAERE is moving from 4 to 6 issues per year. This will significantly reduce the delay between each paper’s acceptance and publication, and allow us to continue to publish the very best papers in the field. Please continue submitting to the journal and encourage your colleagues to do the same!

Fast Turnaround Times

JAERE has some of the fastest turnaround times in the business! In 2018, our average time to rejection after review was 67 days, and the average time to receive news of an R&R was 75 days.

High Impact

Although JAERE does not yet have a formal impact factor, we are working hard to obtain one. In the meantime, you should be aware that JAERE is high-impact; according to Web of Science citations per article, even in our early years of publication JAERE’s citations (2.88 per article) rank favorably with the Journal of Public Economics (2.78 per article), the Journal of Environmental Economics and Management (3.54), the Energy Journal (1.81), and Environmental and Resource Economics (2.27). Additional citation metric comparisons and other reasons to publish in JAERE are available on JAERE’s website.

A Perk for Referees

We are working on a new process that will waive JAERE’s \$100 submission fee for authors who have submitted a timely referee report to JAERE within the previous 12 months. This option will be available via a link on JAERE’s website and should be in place by February 1, if not sooner.

Starting with this note, the JAERE editorial team will send email updates to AERE members twice per year. Please don’t hesitate to ask any of us for additional information. We are the journal of the Association, and we welcome input from all members.

Registration opens February 1 for AERE 2019 Summer Conference

The seventh annual AERE Summer Conference will be held May 30-31, 2019, at the Hyatt Regency at Lake Tahoe, located lakeside in the Sierra Mountain Range and a short walk to Incline Village.

The conference will feature a keynote address by Seema Jayachandran (Northwestern University) as well as sponsored sessions (supported by generous funding from the Office of Response and Restoration (National Oceanic and Atmospheric Administration), the Economic Research Service (U.S. Department of Agriculture), and the National Center for Environmental Economics (U.S. Environmental Protection Agency), general sessions, and a poster session. The abstract submission period is closed.

David Anthoff (University of California, Berkeley) will present a pre-conference workshop on advances in integrated assessment modeling on May 29, 2019.

Upcoming Abstract Submission Deadlines and Regional Conference Dates

- AERE sponsors up to twelve sessions, presenting more than forty research papers, at the Western Economic Association International (WEAI) Annual Conference, held in late June each year. The next WEAI Annual Conference will be held June 28-July 2, 2019, at the Hilton San Francisco Union Square. For full consideration for AERE@WEAI sessions, abstracts must have been received by January 15, 2019.

AERE is an Allied Society of the WEAI so participants in AERE sessions register at the same rate as members of WEAI.

- The Midwest Economics Association (MEA) Annual Conference will be held March 15-17, 2019, at the Hyatt Regency St. Louis at the Arch in St. Louis, MO. AERE sponsors six to eight sessions with up to three dozen research papers at MEA.
